STAKES OFFERED

OPEN: Open to any eligible Irish Wolfhound that has obtained an AKC Qualified Courser certificate. This requirement will be waived for hounds that have earned a Field Championship title from The American Sighthound Field Association (ASFA) or the Canadian Kennel Club (CKC). ASFA or CKC Field Champions must submit a copy of their title certificate to the host club when they enter their first AKC Open Stake. This copy must be included when the results of the trial are sent to the AKC. Hounds that have earned their AKC FC title are not eligible to enter the Open Stake.

OPEN VETERAN: Open to any eligible Irish Wolfhound that is 5 years or older on the day of the trial and also meets the qualifications of Open or Specials Stake.

SPECIAL: Open to all eligible Irish Wolfhounds that have earned their AKC Field Championship titles. LCX points will be awarded from this stake. Qualifying scores earned from the special stake will count toward a Senior Courser or Master Courser title.

Hounds under disqualification from AKC, ASFA or CKC Field Trials may NOT be entered.

Rosettes and Trophies

First – Blue, Second – Red, Third – Yellow, Fourth – White, Fifth – Pink

Best of Breed – Purple & Gold

Additional awards will be offered through the generous donations by members of the IWCA. Donors are listed elsewhere in this premium list.

Eligibility and Conditions of Entry: Only purebred Irish Wolfhounds may be entered. Hounds must be 1 year of age older on the day of the trial. All hounds will run twice, in trios if possible or braces, unless excused, dismissed or disqualified. Bitches in season and lame hounds at roll call will be excused and their entry fee refunded. Hounds not present at roll call will be scratched after a five minute grace period.

Course Plan:



Battery powered, continuous loop lure machines will be used. The lure will consist of white plastic strips or bags. Backup equipment will be available. The course will be reversed for the finals, runoffs and Best of Breed. The club reserves the right to alter the course plan as required by weather and/or field conditions on the date of the trial.
